Director Hardy: why are there 2 people riding around checking meters? Isn't that a one person job? General Manager says one is in training.

Director Harding wants to know how many employees and what they do. General Manager reports 2 office workers, 2 operators,7 maintenance workers of the 7-1 mechanic, 1 water operator...General Manager has offered to make a diagram of their jobs, he needs to post job descriptions.

Director Harding: What is the rent on Poppy's? GM: \$450 a month Director Harding: if they are paying that much, why are they cleaning the bathrooms and not housekeeping for the lodge??

Director Harding: What is the rent on Hi-County? GM: \$250 a month, but they are responsible for all maintenance and utilities and upkeep.

Director Harding: How many pieces of heavy equipment does TWSD have? And what are they? 1 Bulldozer, 2 backhoes, 3 dump trucks, 1 compactor, 1 frontend loader that is basically junk.

How many vehicles? Are they all running?

6 vehicles, 1 not running

Director Harding: One last question, can you look into installing GPS devices and software for tracking the vehicles, in all vehicles, yes it can be done.

Manager's Report 03/21/22

In February we had a 71.25% water loss. Our filtration plant is doing good, producing 35% of our water. The Spring is doing the same, putting out about 180gpm to 200gpm. There are now 12 water meters waiting to be installed, and a backlog of 11 line extensions to do. The system currently has 537 active meters, out of a total of 891 services. This last 5 weeks - 7 meter installs and 1 line extension were completed. Over the last month, we have had quite a few leaks in the system... there were 11 in 1 area... all in the same isolated pressure zone off Tank #3.

Our grants from the State are moving along, the Colonias Grant has been completed, reviewed, and hopefully soon will be approved. Our \$565,000 in Capital Outlay money is uncertain – but some of it (the backhoe, with DFA) seems to be moving ahead.

The dump area behind the District Barn is closed, blocked off, and has a no dumping sign. A solar street light Michael found has been ordered for the dumpster area, and will be installed soon. Also, JTL Auctions will be rescheduling a visit to look things over in preparation for a possible auction of old equipment, etc...

We are training our new Accounting Clerk... this is moving along well and things are getting caught up. The last audit has been released and the District did very well. Our sale of surplus lots went well, we sold 11 lots for an overall total of about \$55,000 and bidders are currently completing their payments to get the deeds. We are currently concentrating on getting the accounting system back online and updated, so there will be some solid figures to work with.

The grader will be out full-time soon... weather permitting. Call the office and put in a work order if your road has an especially bad or dangerous problem.
