General Manager's Report

23 August Tank #3 was inspected, (photos were shown at meeting) much damage due to time and wear was noted. Rust, corrosion, loss of interior coating, interior supports giving way. Support structures buckling, bolts holding supports gone. Leaks at sides and on the bottom of the tank were seen. The tank is leaning approximately 4 degrees, the floor thickness which should have been ¼ inch thick was at most 1/10th inch thick.

The state has okayed emergency measures releasing grant monies early to allow other grant monies to be used towards the purchase of a new tank. Grant monies previously set aside for underground reservoir (project had been cancelled) has been authorized to be diverted to help relieve the money crisis caused by the loss of Tank#3 in seeking replacement.

4 Distribution line leaks fixed; 6 meter box leaks repaired. 17 new work orders for road repairs, 4 closed, the rest awaiting time for the crews to get to them.
