NOTICE TO TIMBERON WATER AND SANITATION DISTRICT CUSTOMERS OF PROPOSED WATER RATE INCREASE – GENERAL METERED SERVICE

Timberon Water and Sanitation District ("Timberon") intends to increase water rates for all of its ratepayers. The proposed rate increases by new and changed rates would apply to all customers who receive water services. Pursuant to the New Mexico Public Regulation Commission's (NMPRC) Orders of May 17, 2023 and November 30, 2023 ("Orders") Timberon has been ordered to file with the NMPRC Timberon's proposed new rates by no later than May 30, 2024, which rate proposal shall be accompanied by an Advice Notice and a cost-of-service study showing Timberon's audited expenses for its water services for the twelve month period ended September 30, 2023, and testimony and documents explaining how any costs shared with Timberon's other functions are allocated. Timberon has also been ordered to file with its proposed new rates a schedule showing its costs adjusted for any known and measurable changes that will occur by May 31, 2024, and testimony explaining and justifying each adjustment.

10. WATER CONSERVATION SURCHARGES:

The following surcharges are applicable only when the Timberon Water and Sanitation District Board of Directors declares by resolution that the Water Conservation Policy Phase II or Phase III is in effect. They will be added to the regular General Metered Service charges for any usage above the established baseline amount of 9,000 gallons.

During Phase II, any usage over the established baseline will be surcharged an additional \$1.00 per thousand gallons.

During Phase III

- usage from the established baseline to 20,000 gallons will be charged an additional \$2.50 per thousand gallons
- usage between 20,001 and 30,000 gallons will be charged an additional \$2.50 per thousand gallons
- usage between 30,001 and 40,000 gallons will be charged an additional \$3.00 per thousand gallons
- usage between 40,001 and 50,000 gallons will be charged an additional \$3.50 per thousand gallons, and,
- usage above 50,000 gallons will be charged an additional \$4.00 per thousand gallons.

For treated water service using a larger meter, the same surcharges will apply. Both Phase II and Phase III Rates apply to residential and commercial service.

11. BULK WATER RATE:

For those customers that live in unserved areas of Timberon and who do not have regular metered service, bulk water service will be available. The rate for bulk water will be the same as for those customers who are connected to the Timberon system. Any increase/decrease in customers' rates will also apply to bulk water users. Water conservation surcharges will also apply to bulk water users.

Bulk water service will be provided through a separately metered connection at the Community Center/Lodge. Bulk water customers will be responsible for providing containers and for transporting their bulk water. Bulk water may be purchased ONLY if customer's lot is in a noservice area. Customers who own or control metered water or standby lots are not eligible for bulk water.

Customer charge applies to all customers.

12. TAX ADJUSTMENTS:

Tax adjustments apply to all rates and charges.

Timberon intends to file with the NMPRC the schedule of the proposed new rates no later than May 30, 2024.

Timberon will notify any ratepayer who requests to be notified of the actual date on which Timberon actually files with the NMPRC the Advice Notice proposing the new and changed rates and charges.
